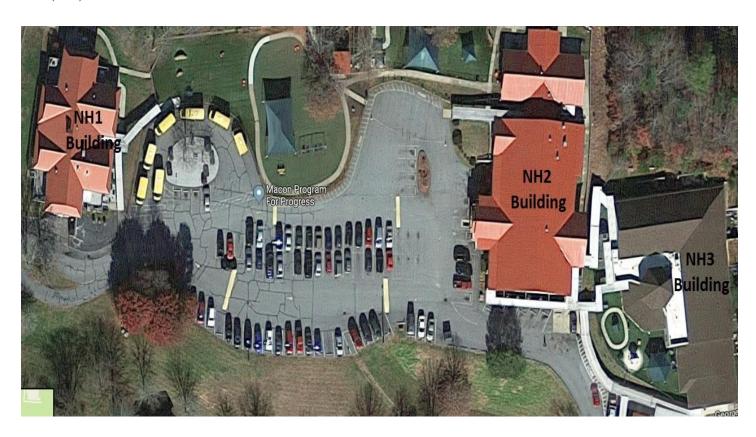

0-5 HEAD START POLICY COUNCIL for 2020-2021

The Office of Head Start requires the establishment and maintenance of a formal structure of shared governance through which parents can participate in policy and decision making for the program. For this purpose, a Policy Council has been established. In addition, Policy Council meetings are a great way for parents to become involved, work on their leadership skills, and learn more about Head Start operations. The bullets below provide details about the council:

- 0-5 Head Start Policy Council membership is made up of 51% parents of enrolled children and 49% community partners.
- Policy Council Parent Representatives and Alternates are elected at the first parent meeting in September.
- Members receive orientation prior to their first Policy Council meeting and ongoing training and guidance on governance and relevant issues at regular meetings.
- Policy Council participates in on-going program planning, approvals and funding decisions.
- Members receive packets prior to each meeting consisting of an agenda and items for review, discussion and when appropriate, approval.

PROGRAM AUDIT OUTCOMES

The outcome of the most recent Focus Area One Federal Monitoring Review with was completed in February 2020, indicated that all areas were found in compliance.

The MPP 2020-2021 agency audit had no findings.

PROGRAM DESCRIPTIONS

EARLY HEAD START (EHS) serves children ages six weeks to three years of age and pregnant women. Enrollment eligibility is based on federal poverty guidelines, child's age, documented disability, family type, and other eligibility factors. Children with disabilities are served in a fully inclusive classroom environment. When a child transitions from Early Head Start to Head Start, the family must reapply for Head Start program. Center hours are 9:00am-3:00 pm Monday-Friday year round.

EARLY HEAD START HOME BASE: A full range of EHS services are provided through weekly home visits to each child enrolled in the Home Base program option. The Home Base Educator provides child-focused visits that promote the parents' ability to support their child's development. These visits last about an hour and a half each. Approximately twice per month, the program offers opportunities for parents and children to come together as a group for learning, discussion, and social activities. EHS Home Base operates year round.

EHS PREGNANT MOMS: This education based program option focuses on women who are pregnant for the first time or who may be experiencing a high-risk pregnancy. Family members may enroll their baby in Early Head Start at six-weeks of age. Slots are limited.

HEAD START (HS) serves children ages three to five years. Enrollment eligibility is based on federal poverty income guidelines, child's age, documented disability, family type, and other eligibility factors. Children with disabilities are served in a fully inclusive classroom environment. Bus services are available for children assigned

to the NH I center upon request and availability. Classroom hours are 8:45 am-3:15 pm Monday-Friday from late August through early June.

NC PRE-K is a state-sponsored school readiness program that serves 4-year-olds, based on need and NC Pre-K criteria. Hours of care are 8:45 am - 3:15 pm – Monday- Friday for ten months.

EXTENDED DAY: Before/after care is for parents who are in school, training, or working at least 20 hours per week, based on state subsidized childcare guidelines. Extended morning hours are from 7:30 am until 9:00 am and afternoon hours are from 3:00 pm until 5:30 pm. There is a fee for services with these extended hours. We collaborate with Social Services for the families to potentially receive Subsidy.

 - c. Increase staff involvement within program planning
 - d. All service areas will be monitored into program's Child Plus system
- 3. The program will increase community awareness of services offered:
 - a. Map out community to find service gaps
 - b. Develop branding strategies
 - c. Partner with MCS to explore system to track former HS children through 3rd grade
 - d. Program meets at least 50% of original Federal Match
- 4. Improvement of facilities and series to children, families, staff and community
 - a. Conduct a program-side facility analysis
 - b. Determine program impact on families
 - c. Research a credit card payment option for monthly subsidy payments
 - d. Elevator added to NH2 for ADA regulations
 - e. Designate and adapt indoor play area for 3-5 year olds

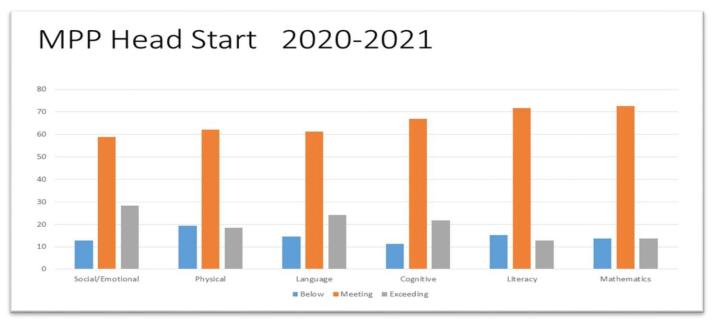
EDUCATION AND SCHOOL READINESS

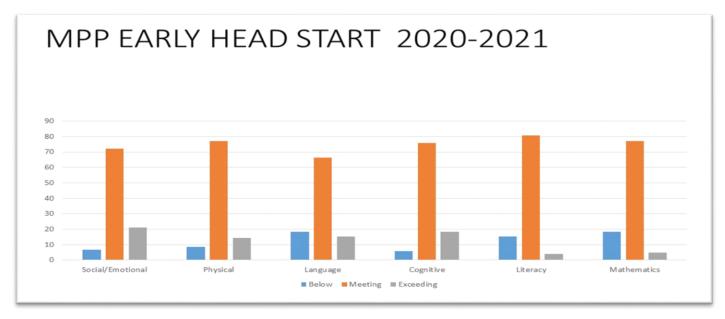
PREPARING CHILDREN FOR KINDERGARTEN

Children's experiences and the skills and characteristics they develop during the preschool years are critically important to their success later in life. MPP 0-5 Head Start's services prepares children for kindergarten using the following strategies:

Our comprehensive educational program focuses on School Readiness Goals that include physical
development and health, social and emotional development, approaches to learning, logic and reasoning,
language development, literacy knowledge and skills, mathematics, science, creative arts expression, and
social studies skills.

- The curriculum, The Creative Curriculum for Preschool, aligns with the North Carolina Foundations for Early Learning and Development, which is a common set of goals and developmental indicators for children beginning at birth and is a shared vision for what children should learn before they enter kindergarten. Curriculum implementation is individualized in order to help each child meet his/her educational potential.
- The assessment tool, Teaching Strategies Gold is used to record and track progress toward meeting School Readiness Goals. This system is used for all children birth-5. While the assessment is primarily focused on tracking children's developmental progress, enabling teachers to plan both individually and whole group learning experiences, it is also used as an opportunity for families and staff to set goals and identify "next steps" for school and home.





TRANSITION ACTIVITIES

MPP 0-5 Head Start Program supports successful transitions for enrolled children from home into Early Head Start or Head Start, from EHS to Head Start, and from Head Start to kindergarten. Staff coordinates with schools and other agencies to ensure transfer of relevant data to the receiving school; performs outreach to encourage communication between staff and school counterparts; initiates meetings involving Head Start

teachers, parents and kindergarten teachers; and plans joint transition related training for staff and parents.

Although the COVID-19 pandemic interrupted some of the planned activities, the program adjusted strategies to ensure positive and smooth transitions for all children occurred. Activities included:

- Transition planning initiated between FSA and families
- Collaborating with Macon County Schools about transitioning children
- Distanced home visits to deliver home activities packets
- Utilizing Remind, Facebook, YouTube, and Zoom to keep connected to families and children
- Providing parents with online resources for at home learning opportunities
- Early Head Start Transition meeting for parents via the Zoom format
- Back to School Angels backpack project suppling backpacks filled with school supplies

- Goal 4: Children will begin to learn and internalize rules, routines, and directions.
- Goal 5: Children will begin to develop and demonstrate a positive sense of self, competence, and an identity that are rooted in their family and culture.

Approaches to Learning Goals for Infants and Toddlers

- Goal 1: Children will demonstrate interest, curiosity, and eagerness in exploring the world around them.
- Goal 2: Children will demonstrate persistence in learning and discovery.
- Goal 3: Children will learn and use words to describe what they are thinking and doing.

Language & Literacy Development Goals for Infants & Toddlers

- Goal 1: Children will demonstrate receptive and expressive language skills and communication strategies in their home language/s.
- Goal 2: Children will understand and begin to use oral language for conversation and communication.
- Goal 3: Children will hear and distinguish the sounds and rhythms of language.
- Goal 4: Children will begin to learn and demonstrate how print works.
- Goal 5: Children will engage with stories and books.

Cognition Goals for Infants & Toddlers

- Goal 1: Children will learn and begin to use math concepts during daily routines and experiences.
- Goal 2: Children will use all of their senses to investigate their environment to discover what objects and people do, how things work, and how they can make things happen.
- Goal 3: Children will begin to develop and demonstrate the ability to remember and connect new and known experiences and information.

Perceptual, Motor & Physical Development Goals for Infants & Toddlers

- Goal 1: Children will develop control of large muscles for movement, navigation, and balance.
- Goal 2: Children will develop control of small muscles for manipulation and
- Goal 3: Children will learn and begin to demonstrate healthy and safe habits

HEAD START GOALS 3-5 year olds

Social & Emotional Development Goals for Preschool

- Goal 1: Children will engage in and maintain positive adult-child relationships and interactions.
- Goal 2: Children will engage in and maintain positive peer relationships and interactions.



- Goal 3: Children will display levels of attention, emotional regulation, and behavior in the classroom that are appropriate to the situation and the supports available.
- Goal 4: Children will learn and internalize (follow) classroom rules, routines, and directions.
- Goal 5: All children will develop and display a sense of self, confidence in their abilities, and a strong identity that is rooted in their family and culture.

Approaches to Learning Goals for Preschool

- Goal 1: Children will show an interest in varied topics and activities, an eagerness to learn, creativity, and independence in their interactions with activities and materials.
- Goal 2: Children will demonstrate persistence when working with materials, activities, and information.
- Goal 3: Children will learn and use words and concepts that parallel the information available in activities and materials.

Language & Literacy Development Goals for Preschool

- Goal 1: Children will build, use, and comprehend increasingly complex and varied vocabulary.
- Goal 2: Children will use and comprehend oral language for conversation and communication.
- Goal 3: Children identify and discriminate sounds within words, as separate from the word itself.
- Goal 4: Children will use and understand print as a system of visible marks that represent the sounds within words and words themselves.
- Goal 5: Children will engage with literature in developmentally appropriate ways.
- Goal 6: Children who are dual language learners (DLLs) will demonstrate increased competency in their home language while developing proficiency in English.

Cognition Goals for Preshool

- Goal 1: Children use math regularly and in everyday routines to count, compare, relate, identify patterns, and problem solve.
- Goal 2: Children use observation and manipulation, ask questions, make predictions, and develop hypotheses to gain a better understanding of information and activities in their surroundings.
- Goal 3: Children use their skills in remembering information and being aware of their own thinking.

Perceptual, Motor & Physical Development Goals for Preschool

- Goal 1: Children will demonstrate control of large muscles for movement, navigation, and balance.
- Goal 2: Children will demonstrate control of small muscles for such purposes as using utensils, self-care, building, writing, and manipulation.
- Goal 3: Children will identify and practice healthy and safe habits.

FAMILY OPPORTUNITIES & ACTIVITIES

Comprised exclusively of parents of currently enrolled 0-5 Head Start children. Meetings are held based on a schedule determined by the parent's availability. All parents are encouraged to join in and help plan activities and events. In the 2020-2021 school year parents/caregivers had the opportunity to participate in 23 PARENT ENGAGEMENT MEETINGS/ACTIVITIES.

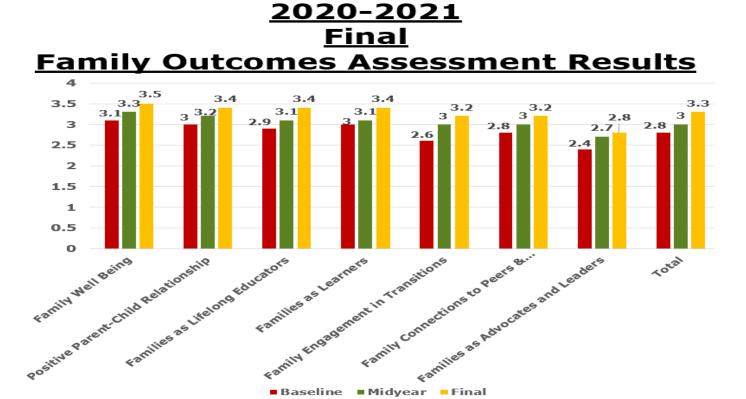






FAMILY OUTCOMES

Three times per year, a Family Service Advocate (FSA) and family members collaborate with one another to complete a Family Outcomes Assessment, which targets seven specific Family Outcomes (See Chart for Outcome Titles). Each outcome has multiple criterion that are rated individually from one to five with one being "In-Crisis" and five being "Thriving". Questions progressively increase in depth from the beginning of the assessment focusing on basic life skills to the end of the assessment focusing on advocacy and leadership.



The results of the assessment along with the family members' expertise on their children and family are then used to create Family Goals. Parents, FSAs, teachers, and community members work together throughout the year to increase family functioning in each outcome area and towards achieving the family's goals. Increases in Family Outcomes may naturally lead to positive child outcomes and growth in parenting skills, in parental selfesteem and in parental trust in program and community based family service providers.

MPP is an agency that encourages community volunteers. Volunteers enhance services, provide positive role models, and promote connections to the broader community. MPP is always looking for ways to recruit current parents, former participants/relatives of the Head Start Program, and other folks from the community that have a special talent or a love for the children of our community. The 0-5 Head Start program is federally funded. With each annual grant award, the program is required to match 20% in In-Kind funds through local support and parent volunteer hours. Parents can help teachers during a field trip and get volunteer credit for their time. Parents should always fill out an In-Kind Volunteer Record form; include date of trip, where the trip took place, and how much time you spent helping teachers supervise children.

EMERGENCY PREPARDNESS

In compliance with the North Carolina Division of Child Development and Early Education and the Head Start Performance Standards, MPP 0-5 Head Start has an Emergency Preparedness and Response Plan in place. Fire drills are practiced monthly and Emergency Lockdown (shelter-in-place) drills take place quarterly. The Emergency Preparedness team partners with local emergency service contacts in order to update and address any concerns for maintaining and improving procedures to ensure the safety of children, families, service providers, visitors, and staff. Surveillance cameras are located in public areas, classrooms, entrance doors, and parking lots. Parents and staff are assigned door codes and cameras are constantly recording with back-up in place for security purposes. MPP 0-5 Head Start, in collaboration with area family and child service providers, maintained partnerships to help address the diversity of interests and needs of enrolled children, families, and staff. A resource list, published in the Parent Handbook, provided families with contact information on local family support services.

COMMUNITY OUTREACH

MANNA POP-UP FOOD BANK: Our first MANNA POP Up was on 6/4/19. Expecting only about 50 people and located here at MPP on the NH-1 sidewalk, we had about 176 individuals who came for food. Each month we kept growing and had to change locations and continually ask for more food. MANNA kept increasing our quantities and our community kept helping us change locations. Each time we held an event we learned from our volunteers and clients what was working and what needed to be tweaked so we could have the smoothest process as possible. We have been blessed to have so many wonderful volunteers in our community and even the National Guard to help us serve our people. We have adjusted from the grocery shopping style method to the drive thru distributions due to COVID-19. In May, 2020 we served our largest amount of people with a whopping 1,282 individuals/409 households. As we still have food insecurities among us, we hold a MANNA Community Market once a month. HOLIDAY ANGELS: MPP has operated the Holiday Angels project for over 30 years with the committed support of local groups, clubs, churches, businesses, schools and individuals. The program is self-supporting and any monetary donations are earmarked in the Holiday Angels budget and utilized for program operations including purchasing gifts, toys, clothing, shoes, food, gift cards, addressing family crisis situations and even purchasing loads of wood as requested for families who are not matched with a sponsor. \$10,590 was donated from 23 donors. 49 sponsors were directly linked with families and Adults to shop for the holidays. Holiday angel committee only needed to shop for 40 children and 8 special needs adults after applicants and sponsors were matched. 129



families took part in the holiday angel program to include 316 children and 56 Elderly and Special Needs Adults.

BACK TO SCHOOL ANGELS: MPP 0-5 Head Start has operated Back to School Angels for many years. This year we served 40 Head Start children transitioning to kindergarten and 29 additional siblings' ages 6 to 17 years of age. With the help of community volunteers, the MPP Back to School Angels project provided 69 backpacks to Head Start children entering kindergarten and their siblings.
